## Key findings

The decision establishing FP7<sup>1</sup> has set a target for 15% of EU funding under the Cooperation Programme to go to SMEs.


The present report is the tenth of a series of reports whose primary aim is to monitor the implementation of the above mentioned target.

In addition to reporting on the 15% target of the Cooperation Programme, the report provides detailed data on SME participation across FP7.

The previous issue of this report –published in October 2012 – highlighted that 16.3% of the total Cooperation Programme used budget went to SMEs. This figure further progressed to 16.9% over the past nine months.

The main part of Cooperation Programme consists of the ten Thematic Priorities.

The graph below shows the percentage of the EU contribution going to SMEs for all thematic priorities combined and for each one of them individually.


By the end of June 2013, SMEs made up 19.1% of all participations in the Cooperation programme, as will be detailed in Chapter 2 of this report.

This report also provides in-depth statistics about the composition of project consortia: 74.6% of all the grant agreements in the thematic priorities involve at least one SME and 11% of all the project consortia are led by an SME coordinator. On the basis of the latest figures, the average EU contribution going to SMEs participating in thematic research projects is at € 284,000 per project. This is about € 9,000 more or 3% higher than the figure reported in October of last year, in the ninth issue of this report.

The total number of participations registered under FP7 – including Research for the Benefit of SMEs and the Marie-Curie Actions – is close to 106,000 now, and includes 19,300 SME participations, receiving an average EU contribution of € 253,000. The SME participations represent 11,260 unique<sup>2</sup> SMEs, while 24,800 unique organisations have participated in FP7 so far. This means that about 45% of the organisations participating in FP7 are SMEs.

Graph 2 below shows the evolution of the EU contribution share going to SMEs under the FP7 Cooperation Programme. The graph shows a significant increase in EU contribution going to SMEs for all thematic priorities after 2011. This is because many work programmes of 2011 and 2012 included measures designed to increase SME participation, such as ring-fenced budgets, or the inclusion of topics of special interest to SMEs etc.

## Overview of FP7

FP7 has five specific programmes. The table below summarises the SME-related key figures for the entire framework programme and for each of these specific programmes.

(°) Besides the thematic priorities (themes), this figure also includes the grants to ESA, the Joint Technology Initiatives (JTIs) and the General Activities such as the CORDIS services, the horizontal ERA-NET scheme, Research organisations in the EU, Strengthened coordination with EUREKA, Scientific and technological cooperation activities carried out in COST, and under the European Metrology Research Programme.

As expected, the Capacity Programme – with its SME-specific measures under Research for the Benefit of SMEs – devotes the highest percentage of its EU contribution to SMEs (32.1%), which corresponds to about €1.03Billion.

In absolute numbers, the highest EU contribution in funding provided for SMEs under FP7 (i.e. about €3.6 billion) is made under the Cooperation programme, which devotes 16.9% of its overall budget to SMEs.

The EU contribution to SMEs under the People programme can mainly be attributed to the IAPP and the IAT programmes, which include specific measures meeting SME needs. For this reason, the data contained in Chapter 14 focuses exclusively on those two programmes.

## Chapter 2. SME Participation in the Cooperation Programme (Themes)

The table below provides an overview of SME participation by theme, in terms of EU contribution and in terms of SME participation, both in values and in percentages.




The percentage of EU contribution going to SMEs out of the total contribution is highest for the NMP theme (23.1%), followed by SEC and ENERGY. In terms of monetary EU contribution, first comes the ICT theme with over €943 million, followed by Health and NMP.

## SMEs participations in the Cooperation programme

The graphs below display the data contained in table 2 (above) graphically. ICT attracts the highest absolute number of SMEs, but we can find the highest concentration of SMEs – i.e. participations expressed in percentage of the total –under the NMP thematic priority.




*Graph 3: SME participations by theme*




*Graph 4: Participations by theme – SMEs versus all – in percentages*

## Grant agreements that include at least one SME

SMEs are fairly well represented in the consortia that have signed grant agreements with the European Commission under the Cooperation programme. Overall, 74.6% of the project consortia that have concluded grant agreements under the various thematic priorities include at least one SME. Most themes – with the exception of SSH – feature high SME participation, as 67 to 87% of the consortia involved have at least one SME partner, with the TPT thematic priority displaying the highest percentage (87.1%).

## Not the 'usual suspects': good turnover of participating SMEs

The recurrence rate of an organisation is the average number of projects in which an organisation participates.

### Recurrence within the Thematic Programmes

The thematic programmes have about


- 66,057 participations
- 18,294 organisations (individual participants)
- 12,414 SME participations
- 7,482 individual SMEs

### SMEs

SMEs participate in one or two Framework Programme projects. On average, within the same theme, an SME participates in 1.4 projects. There are also SMEs which participate in projects of different themes. Overall, the global 'recurrence rate' of SMEs in the Cooperation programme (over the ten themes) is 1.7. This means that, on average, an SME participates in 1.7 projects.

### All organisations

On average an organisation involved in the Cooperation programme participates in 2.3 projects. Organisations regularly are active in more than one theme (e.g. universities); on average a participating organisation is involved in 3.6 grant agreements within the Cooperation programme.




Over the whole of FP7, an organisation participates on average in 4.3 projects.



**Graph 8: Recurrence rate of SMEs and all participants in the FP7 Specific Programmes**




*Graph 9: Projects coordinated by an SME, expressed as a percentage of the total number of projects*

The graph above provides an indication of the average amount of money received by the SMEs under the different themes. In two themes (Health and SEC) the percentage of EU contribution going to SMEs is higher than the share of participating SMEs.

### SME participation and EU Contribution per Country

Tables 3 to 6 below show the SME share of the EU Contribution in terms of value and as a percentage of the total, and the percentage of SME participation per country for all Member States and FP7 associated countries.

These country statistics enable each Member State to distil the relevant information on the participation of its own organisations/SMEs in the framework programme.

Since many country-specific factors have an impact on the participation of organisations/SMEs to the framework programme (for instance the number of SMEs, the size of the university population, the availability of other national or international funding opportunities in each country and in specific periods of time, and the number of overall applications), it makes little sense to compare between countries.

The analysis of the specific factors and the influence they have on the reported figures are issues that go well beyond the scope of this report.




